Emergency Assistance

City of Portland Emergency Assistance: Households can apply for \$250 in emergency assistance beginning Monday, April 27 at 10am by contacting 2-1-1 or going to https://www.211info.org/covid19. Applications from eligible households will be processed on a first-come-first-served basis.

To be eligible, a household must be experiencing a loss of employment, income, dependent care, or some other hardship as a result of the COVID-19 pandemic *and* earning (documentation required) no more than <u>50% Area Median Income</u> prior to any loss of employment or income due to COVID-19.

City of Hillsboro Rent Assistance: The City has also dedicated \$100,000 for rental assistance to help households struggling to pay rent. Requests for emergency rent assistance can be made by calling Community Action at 503-615-0770 each business day starting at 9 am.

To be eligible, tenants must be past due on the current month's rent or have received a 72-hour eviction notice for the current month and have a lease or rental agreement in their name.
